You must adhere to the guidelines of social distancing when sitting.

We ask that you pre-register with us to eliminate any delays and to restrict access to the Tax Office. Payments will be accepted only in the forms of Cash/Certified/Business Checks or Money Orders. Separate checks will be needed for Taxes and Premiums.

Upon successful bidding, you will remain in the Court room, social distanced, until all calculated totals will be brought into you. We will take your payment and process a receipt for you.

We ask for your full cooperation and compliance in these matters to assure that we all remain healthy and safe.
