COUNTY OF BURLINGTON TOWNSHIP OF NORTH HANOVER ORDINANCE 2016-03

AN ORDINANCE OF THE TOWNSHIP OF NORTH HANOVER, COUNTY OF BURLINGTON, STATE OF NEW JERSEY, AUTHORIZING THE SALE OF CERTAIN LANDS OWNED BY THE TOWNSHIP OF NORTH HANOVER PURSUANT TO N.J.S.A. 40A:12-13

- **WHEREAS,** pursuant to N.J.S.A. 40A:12-13(b)(5), the Township is authorized to sell by private sale to the owner of real property contiguous to real property owned by the Township provided that the property being sold is less than the minimum size required for development under the municipal zoning ordinance and is without any capital improvement thereon; and
- WHEREAS, N.J.S.A. 40A:12-13(b)(5) further provides that where there is more than one owner with real property contiguous thereto, said property shall be sold to the highest bidder from among all such owners and any such sale shall be for not less than the fair market value of said real property; and
- **WHEREAS,** the Township Committee has determined to sell the real property identified in list attached hereto and made a part hereof, currently owned by the Township of North Hanover, by way of private sale in accordance with N.J.S.A. 40A:12-13(b)(5), as they are not needed for public use; and
- **WHEREAS,** in accordance with N.J.S.A. 40A:12-13(b) (5), on January 13, 2016, all property owners owning property contiguous to each of the properties identified on the attached list were mailed written notice by way of U.S. regular mail and certified mail, return receipt requested, informing them of the Township's intention to sell the subject real property and requesting that they submit a bid for the real property on or before February 1, 2016; and
- **WHEREAS**, the Municipal Clerk received bids for each of the properties identified on the attached list from the persons identified therein as "bidder" and for the amounts listed thereon; and
- **WHEREAS**, the Tax Assessor for the Township of North Hanover has determined that the bids received are not less than the fair market value for each of the properties listed on the attached property list.
- **NOW, THEREFORE,** be it ordained by the Township Committee of the Township of North Hanover, in the County of Burlington, New Jersey as follows:
- Section 1. Pursuant to N.J.S.A. 40A:12-13(b)(5), it is hereby determined that the real property identified on the attached list is not needed for public use.
- Section 2. Pursuant to N.J.S.A. 40A:12-13(b) (5), the Township of North Hanover is hereby authorized to sell each of the properties identified on the attached list to the bidder identified for each property at the bid price set forth in the attached list, which are the highest and only bids received from the contiguous property owners and the Township Attorney shall take all steps necessary to effectuate the sale and closing for the subject real property.
- Section 3. The Clerk shall provide the requisite notice of the sale of the aforesaid properties in accordance with N.J.S.A. 40A:13 (b) (5).
- Section 4. In the event that any portion of this ordinance is determined to be invalid, such determination shall not affect he remaining portions of ordinance, which are hereby declared to be severable.
- Section 5. All ordinance or parts thereof, which are inconsistent with the provisions of this Ordinance, are hereby repealed to the extent of such inconsistency.
- Section 6. This ordinance shall take effect immediately after final passage and publication according to law.

ORDINANCE 2016-04

CALENDAR YEAR 2016

ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A: 4-45.14)

WHEREAS, the Local Government CAP Law, N.J.S. 40A:4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to 0.00% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and

WHEREAS, N.J.S.A.40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and

the 0.00% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and

WHEREAS, the Township Committee of the Township of North Hanover in the County of Burlington finds it advisable and necessary to increase its *CY2016* budget by up to 3.5% over the previous years final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and

WHEREAS, the Township Committee of the Township of North Hanover in the County of Burlington hereby determines that a 3.5% increase in the budget for said year, amounting to \$84,077.07 in excess of the increase in final appropriations otherwise permitted by the Local Government CAP Law, is advisable and necessary; and,

WHEREAS, the Township Committee of the Township North Hanover of in the County of Burlington hereby determines that any amount authorized herein above that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Township Committee of the Township of North Hanover in the County of Burlington, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2016 budget year, the final appropriations of the Township of North Hanover shall, in accordance with this ordinance and NJ.S.A. 40A: 4-45.14, be increased by 3.5%, amounting to \$84,077.07, and that the CY 2016 municipal budget for the Township of North Hanover be approved and adopted in accordance with this ordinance; and

BE IT FURTHER ORDAINED, that any amount authorized herein above that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

2016-05 An Ordinance Amending Title 2, Chapter 2-060, Section 2-060.3 of the Revised General Ordinances of the Township of North Hanover

ORDINANCE 2016-05 TOWNSHIP OF NORTH HANOVER COUNTY OF BURLINGTON

AN ORDINANCE AMENDING TITLE 2, CHAPTER 2-060, SECTION 2-060.3 OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF NORTH HANOVER

SECTION 1. This section amends the Administrative Code of North Hanover Township Code, Chapter 2 "Administration", by amending Section 2-060.3 that sets forth the appointment of a Chief of Police or Police Administrator, to read as follows [added portions are bolded and underlined; deleted portions have strikethrough]:

2-060 Police Department.

2-060.3 Chief of Police or Police Administrator Civilian Director of Public Safety

A. The governing body shall appoint a <u>eChief</u> of <u>pPolice</u> or a <u>police administrator</u> <u>Civilian Director of Public Safety</u> who shall serve at the pleasure of the governing body and who shall be directly responsible to the governing body for the efficiency and routine day-to-day operations of the police department. The <u>eChief of pPolice</u> or the <u>police administrator</u> <u>Civilian Director of Public Safety</u> shall, pursuant to the policies established by the governing body, <u>and consistent</u> <u>with the requirements of applicable statutes and particularly N.J.S.A.</u> <u>40A; 14-118</u>:

- 1. Administer and enforce rules and regulations and special emergency directives for the disposition and discipline of the force and its officers and personnel;
- 2. Have, exercise and discharge functions, powers and duties of the force;
- 3. Prescribe the duties and assignments of all subordinates and other personnel;
- 4. Delegate such of his authority as he may deem necessary for the efficient operation of the force to be exercised under his direction and supervision; and
- 5. Report at least monthly to the governing body in such form as shall be prescribed by the governing body on the operation of the force during the preceding month, and make such other reports as may be requested by the governing body.
- 1. Be responsible for the proper and efficient conduct of all public safety functions of the Township, including emergency management, but excluding the functions of the Fire Department.
- 2. Have the authority, subject to appropriate personnel policies and procedures, regulations and statutes, and subject to approval by the Township Committee, to hire, transfer, promote, demote and/or discharge any employee, uniformed and non-uniformed, within the Police Department. The Chief of Police or Civilian Public Safety Director shall also have the authority to impose lesser forms of discipline than demotion or discharge without the approval of the Township Committee, but nevertheless subject to all appropriate employment rules, regulations and laws;
- 3. <u>Direct the daily operations of the Police Department, including allocating assignments and instruction to police officers and employees of the Police Department;</u>
- 4. Establish policies for the operation and administration of the Police Department;
- <u>5.</u> <u>Determine internal organization of the police force;</u>
- 6. Administer and enforce rules and regulations and special emergency directives for the disposition and discipline of the force and its police officers and employees;
- 7. Prescribe the duties and assignments of all police officers and other personnel;

- 8. Delegate his/her authority as he/she may deem necessary for the efficient operation of the force to be exercised under his/her direction and supervision;
- 9. Report at least monthly to the appropriate authority in such form as the appropriate authority shall prescribe on the operation of the force during the preceding month and make such other reports as may be requested by the appropriate authority;
- 10. Formulate, implement and issue rules and regulations;
- 11. Analyze crime trends and statistics to ensure that the agency makes the best use of available funds, personnel, equipment and supplies;
- 12. Provide police officers and employees of the Police Department with guidance and advice and supervise their work to see that proper procedures are followed, that reasonable standards of workmanship, conduct, and output are maintained, and that desired police objectives are achieved;
- 13. Direct the establishment and maintenance of police records and files;
- 14. <u>Issue directives and allocate resources to ensure police protection for emergency and in response to emergent conditions;</u>
- 15. Review for administrative purposes reports prepared by police officers and employees;
- 16. Prepare the Police Department budget;
- 17. Evaluate effectiveness of work programs and procedures of all sections of the Police Department and develop effective work methods for police officers and employees;
- 18. Establish and maintain helpful and cooperative relations with the public, groups, organizations, businesses, etc;
- 19. Designate the streets, avenues and areas of the Township to be patrolled by the police officers;
- **20.** Determine the days and hours of service of the police officers and other employees;
- 21. Determine the periods of time when the police officers respectively may be off duty to make up for overtime service; and
- **22.** Perform all duties authorized by law, rule, regulation or prosecutor advisory or other types of opinions, directives or orders.

B. The <u>eChief of <u>pPolice</u> or the police administrator Civilian Director of Public Safety shall communicate with the designate authority through the police commissioner who shall convey said communications to the governing body.</u>

SECTION 2: This ordinance shall take effect upon final passage and publication according to law.

SECTION 3: All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 4: If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions.

16.080.1 Principal Permitted Uses.

- A. Agricultural uses and farms as defined in §16-060
- B. Detached single-family dwellings
- C. Farms and detached single-family dwellings
- D. Planned Unit Residential Development in accordance with §16-081
- E. Homesteads (See the definition of Homestead in §16-060)
- <u>F.</u> Buildings or land used exclusively by federal, state, county or township government and for public purposes.

SECTION 2. At least three copies of said full Ordinance are on file in the Office of the Municipal Clerk for public examination and acquisition. Copies are available for inspection or acquisition during regular weekday working hours and arrangements have been made for the publication of said proposed Ordinance in pamphlet or other similar form which will be available for purchase from the Township Clerk.

SECTION 3: This ordinance shall take effect upon final passage and publication according to law.

SECTION 4. The Township Clerk is hereby directed to give notice at least ten days prior to the hearing on the adoption of this Ordinance to the County Planning Board, and to all others entitled thereto pursuant to the provisions of N.J.S. 40:44D-15. Upon adoption of this Ordinance, after public hearing thereon, the Township Clerk is further directed to publish notice of passage thereof and file a copy of this Ordinance as finally adopted with the County Planning Board as required by N.J.S. 40:55D-16 and with the Township Tax Assessor.

SECTION 5: All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 6: If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by a court of competent jurisdiction, such portion
