#### **DISCUSSION**

• State of New Jersey School Aid Formula Committeeman Kocubinski gave an overview of the Burlington County Board of Chosen Freeholders Resolution. He would like North Hanover Township to pass a similar Resolution. Mayor Durr expressed concerns and inquired as to the school's position. Committeeman Kocubinski advised he would reach out to the schools and report back. Mayor Durr noted he would welcome some more information. Committeeman O'Donnell noted he believed there was recent activity in the Legislature regarding this issue.

## TOWNSHIP COMMITTEE "COMMENTS"

Committeeman Kocubinski stated the herbicide quotes were discussed by the Treasurer, John Fletcher and the Public Works Contractor and noted we are still awaiting the School's response. He also stated the Recreation Committee was looking to dispose of some old equipment and uniforms. Attorney Lozier stated an inventory would need to be completed and then disposal or an auction would need to be discussed. He also noted damaged items should not be put into the stream of commerce and believes donation is not an option. Committeeman Kocubinski stated the blood drive is scheduled for August 2<sup>nd</sup>. He also noted the movie night and fireworks were in the planning stages. He also discussed the playground inspection and believes it is under the purview of Public Works. Clerk Picariello noted the issues were being addressed. Committeeman Kocubinski inquired about the ocean containers that were offered by the base. The Recreation Committee was looking for storage. Mayor Durr noted this offer was a rumor and asked for the person who brought it up to contact him and give him more information. Committeeman Kocubinski stated he would gather more information. He also noted letters being sent to residents by NJNG. He stated the language was deceiving. Mayor Durr noted there is a law that allows for this. Clerk Picariello gave an overview of the activities of the Police Department to assist residents. Engineer Hirsh stated proper notice must occur. Committeeman Kocubinski noted the County hearing is scheduled for June 17<sup>th</sup>. Attorney Lozier stated Attorney Roselli requested an adjournment and was awaiting a call from the Judge about a new date. Attorney Lozier also noted North Hanover Township would be represented.

Committeeman DeLorenzo noted the meeting between Chief Wells and the Chief from Chesterfield regarding the surveying for the Pipeline. Mayor Durr noted the citizens can sign complaints against the NJNG surveyors and the Judge would decide. Committeeman DeLorenzo noted Chief Wells and Sergeant Duff were working well together and the Police Department was coming together.
