### **ENGINEER'S REPORT**

Engineer Hirsh informed the Township Committee of the condition of the Provinceline Road Culvert. Mayor Durr suggested reaching out to Monmouth County Roads and Bridges. Engineer Hirsh gave an overview of whom he had contacted and is awaiting a response. He also noted setting up a meeting with the Mayors of North Hanover and Upper Freehold and both Engineers to discuss these issues going forward. Attorney Roselli will assist in resolving the issue. Engineer Hirsh also stated he was working on updating the Tax Maps.

### ROAD IMPROVEMENT ENGINEER REPORT

Engineer Gibson reported concerns regarding Contract I. He noted he believes there is a bad aggregate coming into the asphalt laid in Myron Hills and Trotters Ridge developments. He was seeking permission to core the roads to confirm his suspicions. There was a general consensus to move forward. Engineer Gibson reported that Contract II is complete. Guardrail will be installed on the north side of the Orr Road culvert. He stated Contract III will be advertised June 6<sup>th</sup> and bids will be due June 22<sup>nd</sup>. It is anticipated that Contract IV will be advertised June 27<sup>th</sup>. The remainder of the Road Program will be underway by summer. Attorney Roselli noted negative experiences with a bidder could be addressed in future contracts.
