ENGINEER'S REPORT

Engineer Hirsh also stated the Provinceline Culvert repair is scheduled to begin July 8th. Deputy Mayor Butler stated she wanted to move forward with the Park Grant.

Engineer Gibson stated Contract II is complete and he was working on the final payment. He stated the successful bidder for 2016 Contract I was Trap Rock Industries. 2016-99 Resolution Authorizing Settlement of Third Round Affordable Housing Litigation with Fair Share Housing Center

RESOLUTION 2016 – 99 TOWNSHIP OF NORTH HANOVER BURLINGTON COUNTY

RESOLUTION AUTHORIZING SETTLEMENT OF THIRD ROUND AFFORDABLE HOUSING LITIGATION WITH FAIR SHARE HOUSING CENTER

WHEREAS, the Township of North Hanover received Substantive Certification of its third round Housing Element and Fair Share Plan (collectively "Compliance Plan") from the New Jersey Council on Affordable Housing ("COAH") on May 14, 2009; and

WHEREAS, the certified Plan was based upon COAH's revised third round "growth share" rules which were subsequently invalidated by the Appellate Division and the Supreme Court wherein the Court directed COAH to engage in new rulemaking and adopt constitutionally compliant third round rules and housing allocations consistent with COAH's prior round rules and methodologies; and

WHEREAS, COAH failed to abide by the Court's rulemaking directives which caused the Supreme Court to issue a decision on March 10, 2015 divesting COAH of further administrative review and rulemaking authority and reassigning this responsibility, including the determination of municipal third round fair share obligations, to the trial courts; and

WHEREAS, the Court's decision further permitted municipalities that were heretofore under COAH's administrative review jurisdiction to transfer to the Court's judicial review jurisdiction to, *inter alia*, continue to receive immunity and repose against exclusionary zoning challenges and builder's remedy litigation; and

WHEREAS, in accordance with the Court's directives, North Hanover Township filed a declaratory judgment action with the Court on June 29, 2015 in the matter encaptioned <u>In the</u> <u>Matter of the Application of the Township of North Hanover</u>, BUR-L-1528-15 (Mount Laurel) which is being case managed by the Honorable Ronald E. Bookbinder, A.J.S.C.; and

WHEREAS, a number of expert reports have been submitted to the trial courts throughout the State opining as to the magnitude of the third round fair share obligations and there is a wide divergence in the calculations made by the experts which has delayed trial courts in assigning housing allocations; and

WHEREAS, Dr. David N. Kinsey, P.P., AICP, is the expert who was retained by Fair Share Housing Center ("FSHC") and he originally determined that North Hanover Township has a third round prospective need (new construction) affordable housing obligation of 192 units running from 1999 to 2025; and

WHEREAS, Dr. Kinsey recently readjusted and refined his calculations in a report issued on May 17, 2016 and concluded that North Hanover's third round prospective need obligation is 145 units; and

WHEREAS, 128 affordable family rental units already exist in North Hanover Township and these units fully satisfy the Township's 25% family rental obligation and its 13% very low income obligation; and

WHEREAS, Judge Bookbinder and Court Master Mary Beth Lonergan, P.P. are encouraging the Township and FSHC to stipulate and agree upon a compromise number to avoid further litigation expense and the parties have agreed, for settlement purposes, that the Township's third round prospective need number is 101 units which is a 30% reduction of Dr. Kinsey's revised estimate of 145 units and which is fully addressed by the 128 affordable family rental units that already exist in the Township; and

WHEREAS, a proposed form of Settlement Agreement documenting the foregoing and setting forth the other terms and conditions of settlement is attached hereto and made a part hereof as Exhibit "A". The terms of the Agreement are incorporated by reference herein as if set forth herein at length; and

WHEREAS, the intent and purpose of this Resolution is to approve the form and content of the Settlement Agreement and to authorize its execution by the Mayor and Municipal Clerk.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of North Hanover that the proposed Settlement Agreement attached hereto as Exhibit "A" is hereby approved as to form and content and that the Mayor and Municipal Clerk be and are hereby authorized to execute the Agreement on behalf of the Township.

DISCUSSION

• Review of quotes for air condition replacement in Police Department There were two quotes reviewed. Committeeman O'Donnell stated he was in the Police Department and feels this is needed. Committeeman Kocubinski stated he also reviewed it and feels it is necessary. There was a general consensus to move forward with the lowest quote from Artic Heating and Cooling.

• North Hanover Township/Upper Freehold jurisdictional issues along Ellisdale-Arneytown Road aka Provinceline Road Mayor Durr gave an overview of his meeting with Upper Freehold Township officials. The Mayor feels we could include this in contract IV of our Road Improvement Program. Deputy Mayor Butler stated this is an ongoing issue and feels an agreement is overdue. Committeeman DeLorenzo stated this was a good idea. Attorney Roselli stated considering the control would be turned over liability issues will need to be addressed. Attorney Roselli stated this agreement should be adopted by ordinance. Committeeman Kocubinski expressed concerns regarding an area of the road. Committeeman O'Donnell also expressed concerns from the bridge to Route 537. Mayor Durr stated that was a separate issue and would be visited at a later date. There was a general consensus to move forward. There was direction given to the Acting Township Clerk to get the results of Upper Freehold's deliberations concerning a maintenance agreement and to inform Upper Freehold of the Township Committee's decision.

• Draft Resolution requesting the NJDEP to deny certificate of approval of the Transco Williams Compressor Station

Mayor Durr reviewed the request regarding the Resolution pertaining to the Compressor Station. He inquired as to the support of Chesterfield Township. He stated our support should be contingent upon Chesterfield Township's view since the Compressor station is in their jurisdiction. Committeeman Kocubinski stated these projects are related concerning the pipeline and the compressor station. Mayor Durr suggested that we reach out to Chesterfield Township and get their feelings and revisit. Attorney Roselli stated the draft is very confusing and infers that Chesterfield supports this. Attorney Roselli noted that he was unsure of the Resolutions intent. Mayor Durr directed the Acting Township Clerk to inquire with Chesterfield Township as to their support or non-support and why. Committeeman Kocubinski stated time constraints should be considered. Committeeman O'Donnell recommended tabling discussion until there is a firm Resolution that Chesterfield Township supports. There was a general consensus to revisit.

TOWNSHIP COMMITTEE "COMMENTS"

Deputy Mayor Butler informed the Township Committee that our Municipal Court Judge would need a medical leave. The Judge is working with the AOC on a temporary replacement. The leave would commence in September.

Committeeman DeLorenzo stated the Chiefs of North Hanover and Chesterfield were working well together concerning the surveying for the pipeline and that packets are available for the public. He also noted the Police presence is being paid for by NJNG. Committeeman DeLorenzo noted the police department is coming along nicely.

Committeeman O'Donnell gave an overview of his ongoing talks with Verizon concerning the wires in North Hanover Township. He met with officials and toured several areas of concern. He was assured safety issues would be addressed and was given a contact for the cable company. He also noted complaints in the Mobile Home Parks were currently being investigated.

Mayor Durr noted the previous meeting, with the Township Tax Assessor. He stated the Assessor was to report solutions, to the technology issues concerning the assessments and wanted the record to reflect there was no report given to date. Mayor Durr commended Attorney Roselli for his years of service and was happy to hear his health has improved.

PUBLIC PARTICIPATION

Questions, comments or statements from members of the public in attendance.

OPEN PUBLIC COMMENT

Mayor Durr opened the meeting to the public.

Mr. Ralph Ruocco – 101 Chesterfield-Arneytown Road – He noted the trespassing signs have been effective during the surveying work and noted pictures were being taken of those signs. He inquired with Mayor Durr about his property signage. The Mayor stated he was remissive and would make sure a sign was placed. Mr. Ruocco stated he was appreciative of the efforts of Committeeman O'Donnell and the wires.

Ms. Agnes Marsala – Chesterfield Township – She stated she did attend the Chesterfield Township meeting and noted the attorney stated the resolution was redundant. She stated these resolutions were helpful in their quest and the intent of this resolution was to oppose the permits. She applauded the Township Committee for their efforts to date. Ms. Martha Vasalka – Bordentown Township – She commended the police departments on creating the complaint packets. She stated this resolutions intent was to encourage the NJDEP not to pass the water quality permit. This was similar as to what occurred in New York. She also noted that this would be revisited with Chesterfield Township.
