DISCUSSION

Mayor DeBaecke noted clean communities grant funds were available. There was an inclination to purchase a gator for gathering trash at the Green Acres Park. Mayor DeBaecke also noted coloring books were purchased for the Schools.

TOWNSHIP COMMITTEE "COMMENTS"

Committeeman Kocubinski noted the recent recreation meeting. He stated the Trunk or Treat was coming along well and there were a lot of logistics. Recreation members, Marie Benedetti and Courtney Zimansky were present. The members noted there was another event going on during Movie night that they were unaware of. There was discussion regarding advertising events. Committeeman Kocubinski noted the police and fire departments were going to participate in the trunk or treat. It was also reported the bylaws were being worked on and Attorney Roselli should review before being accepted.

Committeeman Doyle noted a Federal Emergency management grant opportunity and inquired as to the interest. Mayor DeBaecke stated forward to Clerk Picariello. Committeeman Doyle thanked Alexandra for helping with tonight's meeting.

Committeeman DeLorenzo stated the Clean Up day would be Saturday, October 6th. He also stated electronic recycling is in effect. He mentioned commercial entities taking brush to Herman's and the issues with that. Attorney Roselli stated commercial should not be accepted.
